
"Upscale and Mainstream Green Office Lifestyle in Vietnam"

This is to promote Low-carbon Sustainable Lifestyle amongst consumers group of office workers in Vietnam.

The initiative is within 10 Year Framework of Programme (10YFP/SCP) funded by UN Environment and implemented by Asian Institute of Technology in Vietnam (AIT-VN).

GO implementation: October 2017 – May 2018









Will my office be charged a fee to participate in the project?

GO-VN charges no fee for participation because the initiative is funded by the UN Environment within the framework of the 10-year Framework of Programmes on Sustainable Consumption and Production patterns (10 YFP).

However, GO-VN delivers supports of human resources, training materials and equipment and provide GO certificate.

Cost for at-place training facilities and initiatives (if any) will not be covered by GO-VN.

However, please read the following remarks to fully understand technical supports by GO-VN:

Technical supports by GO-VN:

- Human Resources: trainers and auditors will be assigned by the project to carry out training, consultancy and evaluation for selected offices within the framework of Green Office initiative;
- Training materials and teaching equipment for the offices' GO teams (each participating office will establish a GO team with 20-30 staff);
- Green Office certificate issued by the GO-VN project (if your office meets the GO-VN required standards).

Expenditures that not supported by the project:

- Cost to organize at-place trainings such as meeting room, food/drinks, office equipment, traveling...;
- Cost to implement GO initiatives in your office. This cost will be proposed by your staff/GO team and approved by your board of director;
- Additional trainings/consultancy (if any) that do not belong to GO-VN.

The above contents will be clarified in the Memorandum of Agreement between AIT-VN and your office.



What are criteria for selecting offices?

First, there is no limit on the size of the office. However, the project will only select the offices with a limited working space.

Second, commitment of board of management as well as staff play a key role in the application process.

2. Selection criteria

First, there is no limit on the size of the office. However, the project will only select the offices with a limited working space.

If your organization has different branches in different locations, you should choose only one of them to register for pilot implementation, then replicate the GO model to other branches.

Second, **commitment** of board of management as well as staff play a key role in the application process. GO-VN is looking for the organizations that desire to "green" their office and be willing to invest human resources and finance to innovate.





When will be the deadline for application?

The application will close once GO-VN selects 10 suitable offices in Hanoi, Danang and Ho Chi Minh City.

4. GO-VN Trainers and Consultant/Auditors

The trainer will train your staff on green lifestyle and promote sustainable initiatives, which will help change their consumption behaviors towards green living and reduce the greenhouse gases emission of your office.

The auditor will play two roles of consultant and auditor. The former is to provide in-depth knowledge about greenhouse gases emission reducing and carbon offsetting so that your office can achieve your goals as well as getting Green Office Certificate of the project. The latter is to carry out carbon reduction assessment and review greening level of your office that is base for certification process.

Alongside, GO-VN will supervise and support the implementation of each office.





After signing MOU, what will be processed?

- Assign trainers and consultants/auditors
- Survey to make an agreement on schedule and working process
- Kick off GO programme at your office
- Conduct Green Office lifestyle trainings
- Implement Sustainable consumption/GO initiatives
- Assess improvement
- Provide certification of Green Office Projecti based on greening level



No	Activity	Expected duration
1	Assign trainers and consultants/auditors to your office	1 week
2	Survey your office and work with your representative to make an agreement on schedule and working process (implemented by trainers)	2 weeks
3	Kick off GO programme at your office, with the participation of representative of Management Board, GO team and other stakeholders of project.	1 session (2 hours)
4	Conduct Green Office lifestyle trainings for your staff $(20 - 30 \text{ people}) - \text{GO team}$: $2 - 3 \text{ hours/day x 6 days}$. The schedule of trainings is arranged by the trainer and your office.	1.5 months
5	The office, with the support of trainer and consultant, will carry out: Sustainable consumption/GO initiatives Improvement assessment Sustainable consumption policy establishment	4 – 5 months
6	Conduct assessments by auditor	1 – 2 months
7	Provide certification of Green Office Project (if the office meets all GO-VN required standards)	1 month
